

TERMS AND CONDITIONS FOR PRIORITY PASS (A.P.) LIMITED COMPLIMENTARY MEMBERSHIP DELEGATE PERKS

1. The promoter of this Priority Pass (A.P.) Limited Complimentary Membership (“**Delegate Perks**”) is Priority Pass (A.P.) Limited (“**Promoter**”), a company registered in Hong Kong at 16th Floor, Oxford House, 979 King’s Road Quarry Bay, Hong Kong with registered company number 20162171-000-08-20-0.
2. The Delegate Perks period is open to entries from 01 November 2021 00:01am (HKT) until the virtual booth is no longer accessible to delegates / five delegates meet the required criteria (whichever happens sooner).
3. There will be a total of 5 (five) complimentary passes issued (‘Delegate Perks’). The Perks are Priority Pass Prestige memberships worth US\$429.00 each. This Perk can be redeemed only once by each qualifying delegate. Only fully completed entries received within the Delegate Perks Entry Period will be entered into the Delegate Perks.
4. The Delegate Perks opportunity is only open to qualifying delegates of Hong Kong FinTech Week 2021 entrants aged 18 years or above.

14. Upon acceptance, the Delegate Perks will be sent within 1 (one) week to the selected delegate by email with an online link to the redemption code. The Promoter accepts no responsibility and no liability if the Delegate Perk is lost or damaged whilst in transit to the qualifying delegates.
15. The qualifying delegates agree to take part in reasonable post event publicity and to the use of their names and photographs in such publicity.
16. The Promoter will use the personal data submitted by entrants for the purposes of the Delegate Perks opportunity as well as subsequent marketing from Collinson. This Delegate Perks and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) will be governed by the laws of Hong Kong. Any dispute or claim arising out of or in connection with the Delegate Perks or its formation (including non-contractual disputes or claims) will be subject to the exclusive jurisdiction of the Courts of Hong Kong.
